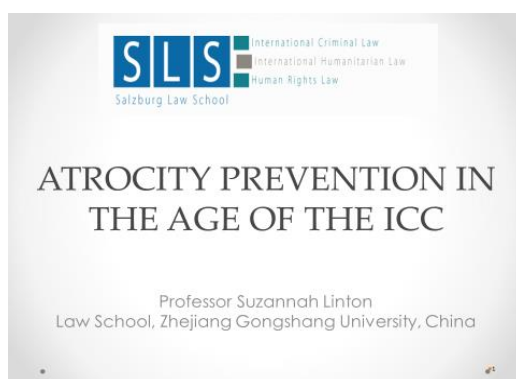


PROFESSOR SUZANNAH LINTON TEACHES AT THE SALZBURG SUMMER SCHOOL'S 20TH ANNIVERSARY SESSION



The Salzburg Law School on International Criminal Law, Humanitarian Law and Human Rights Law (SLS) was the first of its kind, established in 1999 by the late Professor Otto Triffterer at the University of Salzburg, Austria. For twenty years, the SLS has provided a top-level intensive summer course for legal practitioners, academics and post-graduate students who wish to advance their knowledge in international criminal law and related fields. Dr. Astrid Reisinger Coracini, Postdoctoral Researcher and Lecturer in the Department of European, International and Comparative Law at the University of Vienna, has directed the SLS for most of that time.

ZJGSU's Professor Suzannah Linton first taught at the SLS in 2010. This year, the 20th anniversary of the SLS, attracted around 50 well-qualified individuals from all over the world. The thematic focus was 'Towards an Effective International Criminal Justice System in the Era of The Permanent International Criminal Court: Coordinating and Strengthening Enforcement on National, Regional, and International Levels' and the course ran from 5-15 August 2018.
